BCECA Pay Rates Surveys

In March this year, the latest BCECA Engineering Salary Survey was issued and completed by BCECA members, followed by the BCECA Indices Report in April. This report, produced by Alan Jones and Associates on behalf of BCECA, tracks pay movement in the industry for permanent engineering staff (salaries) and for agency personnel (hourly rates). The Indices are calculated using the movement in the medians of the samples for the two groups, as collated in the BCECA Engineering Salary Survey and the BCECA Agency Rates Pay Survey. The Indices Reports are produced twice a year, in April and October, following on from the Engineering and Agency surveys.
