

POWERful Women

On Wednesday 19th May the POWERful Women's network (PFW), of which BCECA is a participant, launched its 2021 statistics on gender diversity at the top of the UK energy sector. The keynote address was given

by UK Energy Minister Rt Hon Anne-Marie Trevelyan MP. Ruth Cairnie, the PFW Chair, then presented the statistics that had been compiled by PwC UK. She commented that whilst the figures had not been impacted by the Covid-19 pandemic, the anticipated improvement in the number of women on energy company boards in order to achieve the PFW 2030 target of 30% had not been achieved.
